Invitation to Bid for **CONSTRUCTION OF DOUBLE BARREL BOX CULVERT AT SANTUYO CREEK** *Located at Barangay Rio Chico*

1. The *Local Government Unit of General Tinio, Nueva Ecija*, through the *LDRRM Fund for Year 2022* intends to apply the sum of *One Million Three Hundred Nineteen Thousand Six Hundred Ninety-Six PEsos and Fifty-Five Centavos (Php 1,319,696.55)* being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Double Barrel Box Culvert at Santuyo Creek. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 2. The *Local Government Unit of General Tinio, Nueva Ecija* now invites bids for the above Procurement Project. Completion of the Works is required *sixty (60) calendar days from the receipt of Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 4. Interested bidders may obtain further information from *Local Government Unit of General Tinio, Nueva Ecija* and inspect the Bidding Documents at the address given below from *8:00 am to 5:00 pm*.
 5. A complete set of Bidding Documents may be acquired by interested bidders on *June 14, 2022 to July 6, 2022* from given address and website/s below *and upon payment for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of five thousand pesos (Php5,000.00)*.
 6. The *Local Government Unit of General Tinio, Nueva Ecija* will hold a Pre-Bid Conference¹ on *June 21, 2022 – 10:00 am* at *2nd Floor, Conference Room, Municipal Hall Building, LGU-Municipality of General Tinio, Nueva Ecija* which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before *July 6, 2022 – 9:00 am*. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on *July 6, 2022 – 10:00 am* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Local Government Unit of General Tinio, Nueva Ecija* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
